    - 1. To promote, stimulate, encourage and foster the dissemination of live music in Quebec, notably through concerts, workshops and various events;
    - 2. Promote recruitment, education, training, orientation, audience development and inclusion.

### **Evaluation criteria**

Quality of the artistic work; Interest and relevance of the project; Feasibility of the project At equal quality, projects involving GMMQ members in good standing and taking place in Quebec will be given preference.

# Up to \$1,500 may be allocated depending on the project. Projects with other sources of revenue will be given preference.

The budget presented includes the musicians' fees (rehearsals and concerts) respecting the minimum standards of the GMMQ, including discounts, contributions and work permits.

# Not eligible: Fellowships, production of sound or audiovisual recordings, launches or promotional activities.

# Conditions for the awarding of scholarships

- 50% of the amount will be paid once the file(s) are selected by the jury
- 50% of the money will be given to the winner(s) upon proof of project completion and filing of the GMMQ contract.
- Please note that failure to provide this evidence will make you ineligible to re-apply to the Music Promotion Fund the Fund reserves the right to reclaim any monies paid.
